# MASONIC LODGE - SASKATCHEWAN SCHOLARSHIPS

There is a scholarship that fits your situation and will make a difference when you feel a bit overwhelmed. There are many more scholarships offered by the individual lodges than we can highlight here. Qualifications for these vary. Generally, all require proof of enrollment, a recent transcript and a completed application. Some may require a letter outlining interests, aspirations, or needs and/or letters of reference.

The Grand Lodge of Saskatchewan, as well as many Lodges, sponsor many awards, scholarships, and bursaries.

Information, along with down loadable applications forms, are listed below.

## **Masonic Youth Trust Fund Scholarships - 6 x \$1,000**

For 2011, six awards are offered to Saskatchewan High School graduates who proceed to an institution of higher learning anywhere in Canada. Selection is based upon academic achievement, leadership skills, community and school activities and special awards. Must be registered for a full academic load for a full academic year as required by the institution chosen. The scholarship will be awarded after proof of registration in the institution and receipt of winner's Social Insurance Number which is required for income tax purposes.

# **Murray Montague Memorial Scholarship - \$1,000**

Offered to Saskatchewan High School a graduate who proceeds to an institution of higher learning anywhere in Canada. Selection is based upon academic achievement, leadership skills, community and school activities and special awards. Must be registered for a full academic load for a full academic year as required by the institution chosen. The scholarship will be awarded after proof of registration in the institution and receipt of winner's Social Insurance Number which is required for income tax purposes.

## Gilbert and Gay Cook Memorial Award - 2 x \$1,000

Offered annually to Saskatchewan High School graduates, with preference to graduates who currently are or were members of the International Order of Job's Daughters or the Order of DeMolay and who will be entering the **University of Regina** or the **University of Saskatchewan**. Selection will be based upon academic achievement and a range of non-academic activities. Must be registered for a full academic load for a full academic year as required by the institution chosen. The scholarship will be awarded after proof of registration in the institution and receipt of winner's Social Insurance Number which is required for income tax purposes.

#### **Edgar Alexander Garton Scholarship - 5 x \$1,000**

Offered annually to undergraduate students who have completed one or more years of University, SIAST, or other post-secondary education. Applicants must be children or grandchildren of a Master Mason in good standing, a resident of Saskatchewan and attending a university, SIAST, or other post-secondary institution in Saskatchewan. Selection will be based upon academic achievement, moral character, sportsmanship and leadership. Must be registered for a full academic load for a full academic year as required by the institution chosen. The scholarship will be awarded after proof of registration in the institution and receipt of winner's Social Insurance Number which is required for income tax purposes.

# **Robinson Trust Fund Bursary in English - 2 x \$500**

Offered annually for one undergraduate from the **University of Saskatchewan** and one undergraduate from the **University of Regina** pursuing a course leading to an Honours or Master's degree in English. Selection will be based on academic achievement and leadership. Recipients of \$1,000 or more in other scholarships are not eligible for this award. Must be registered for a full academic load for a full academic year as required by the institution chosen. The scholarship will be awarded after proof of registration in the institution and receipt of winner's Social Insurance Number which is required for income tax purposes.

# Grand Lodge of Saskatchewan Post Secondary Education Bursary - 2 x \$500

Offered annually to an undergraduate student, after satisfactory completion of at least one complete year of University, who is a resident of Saskatchewan. Selection will be based on academic achievement, moral character, sportsmanship and leadership.

One scholarship to be awarded for the **University of Saskatchewan** and one for the **University of Regina**. Must be registered for a full academic load for a full academic year as required by the institution chosen. The scholarship will be awarded after proof of registration in the institution and receipt of winner's Social Insurance Number which is required for income tax purposes.

## Order of the Eastern Star - Robert Morrison Award - 2 x \$1,000

One award offered annually to a Saskatchewan High School Graduate entering their first year of post-secondary study and one offered annually to a University or Technical School Undergraduate entering their 2nd or subsequent year of post-secondary study. Candidates must be closely related to a current member of a Saskatchewan Eastern Star Chapter and may receive the award only once during their post-secondary career. Must be registered for a full academic load for a full academic year. The scholarship will be awarded after proof of registration in the institution and receipt of winner's Social Insurance Number which is required for income tax purposes.

# Wascana Preceptory No. 51 Knights Templar Scholarship - \$6,000

This scholarship, valued at \$6,000.00 is paid over the fall and winter semesters of each year with the recipient receiving \$3,000.00 each semester. To receive the second payment, the recipient must pass all courses and maintain a minimum 80% average during the fall semester. This scholarship is awarded to a University of Regina student who is registered for full time studies (minimum of 12 credit hours), entering the final year of study in a program leading to a Bachelor of Fine Arts with a major in Indian Fine Arts, Theatre or Visual Arts, Bachelor of Music, Bachelor of Music Education or a Bachelor of Science with a major in Biology, Chemistry or Computer Science. Must be a Saskatchewan High School graduate and have maintained a minimum 80% average in all courses during the third university year of study to be eligible. The recipient will not be eligible for any other scholarship during the term of this scholarship. The scholarship will be awarded after proof of registration in the institution and receipt of winner's Social Insurance Number which is required for income tax purposes.

Some of these scholarships require Masonic affiliation as outlined on the website. Others are open scholarships.
